# **GREEN PROMISES SUPPORT FOR AG**

UNL Chancellor Ronnie Green spoke to a packed crowd of 132 local residents at the 2018 Phelps County **Development Corporation Annual** Meeting on March 22 at the Taste of Texas in Holdrege.

Green complimented Phelps County leaders for their progressive spirit, shared statistics about the University of Nebraska-Lincoln and talked about the future of agriculture.

Prior to Green's speech, PCDC Board President Doug Stevenson shared PCDC and community accomplishments in 2017, including:

- BD's investment of \$300 million in the local plant since 2010,
- Briggs & Stratton's addition of new employees (140 staff now) and their plans for an upcoming expansion,
- PCDC's commitment of \$1 million into a new baseball/softball complex,
- Housing solutions including a housing study, the construction of the Washington Square apartments, five new homes purchased through the down-payment assistance program and the partnership between PCDC and the HDC for a \$1 million housing project,
- Formation of a local builder's bureau to create more opportunities for local contractors.
- PCDC's gift of seven \$1,000 First Impression Grants to local businesses,
- Eight high-demand jobs scholarships awarded to students who plan to return to work in Phelps County,
- A contract with Buxton Co. to encourage and support retail growth,
  - A gap-financing loan to support

the opening of a new business, Lost Way Brewery,

- A publicity campaign to raise awareness of Phelps County as a great place to do business.
- Distributing the Phelps County Business Journal to every household in the county so all residents can be aware of economic development activities and opportunities.

"You should be proud of what you are doing," Green said. "I can tell you that it's not like this everywhere I go. The spirit's different here. I can feel it. You should relish that and be proud of it. The attitude here is that you want to grow, that you want to change and you want to be progressive. And, I just want to tell you that I could feel that here

Green, who was raised on a livestock and grain farm in southwestern Virginia, has served as UNL chancellor for two years. He said the university is growing, and he is looking forward to celebrating

its 150th anniversary on Feb. 15, 2019.

Current enrollment at UNL is 26,079 students with 82 students from Phelps County, and Green said he expects that number to grow by 1,000 students next fall.

Green, who has a strong background in agriculture, said the university is committed to preserving the future of ag in Nebraska and talked about opportunities for growth in agriculture, especially in Phelps County.

He talked about the "golden triangle" of ag production that includes crops, livestock and value-added products, such as ethanol or food.

"When you look at the production zone, and you think of what is ideal for that kind of production system - you sit in it – you sit in a zone that is very ideal for those kinds of enterprises," he said.

He encouraged Phelps County leaders to continue to discuss valueadded ag opportunities.

# WESTCOTT FOLLOWS FAMILY LEGACY IN ECONOMIC DEVELOPMENT WORK

Shane Westcott is carrying on a family legacy as he begins his term on the board of the Phelps County Development Corporation.

Shane's dad, Marvin, served on the Holdrege Industrial Development Council (HIDC) before

he died in 2009 and was passionate about helping Phelps County grow and thrive.

Generations of Shane's family have lived and worked in Phelps County, and Shane also believes it's important to preserve it for future generations.

"Our family is here, and we enjoy raising our kids in a smaller family environment," Shane said. "It's important for our town to be here in the future for everybody."

Shane was appointed to the PCDC board in February to fill the position that was left open after the death of longtime PCDC board member Tim Anderson in October 2017.

"When they approached me to replace Tim, I looked at that as an honor," Shane said. "He did a lot for the town and the area and even the state. He was a family friend. Plus, economic development is big for our town. It's important to keep our community growing and thriving."

Tim and Shane's dad worked together on the

HIDC and economic development in the county.

"Community was important to my dad, my grandfather and Tim," Shane said. "It's nice to be able to continue on some of the work they started."

Shane graduated from HHS in 1996 and then earned a bachelor's degree in agribusiness in 2000 at the University of Nebraska-Lincoln. After graduation, he didn't hesitate to return to Phelps County.

"I always knew I wanted to farm," he said.

He started farming in Phelps County after he graduated from college with "two quarters and an 80" and now continues to grow corn and soybeans in the area.

He will be a voice for agriculture while serving on the PCDC board.

"It's important for economic development groups like PCDC to have an influence in agriculture," Shane said. "It's the biggest industry in our entire state. It's good to have some agricultural businessmen/farmers on the board to make sure their voices are heard."

Shane and his wife, Lacie, have two children: Addison, 8; and Gavin, 5. Shane's past community involvement includes serving on the board of the Holdrege Country Club and Pheasants Forever and being involved in the Future Fund at the Phelps County Community Foundation.

Outside of work and family activities, Shane enjoys hunting, golfing, traveling and watching Husker football.

### PCDC HONORS ANDERSON WITH MEMORIALS

PCDC will honor former long-time board member Tim Anderson by contributing toward a park bench at the hiking trail at Johnson Lake and by planting a flowering Japanese Lilac tree in Holdrege's North Park.

Maybe it's the surprise of stepping out of their vehicle in small town Nebraska and entering into a store that looks like it's in New York City. # Langenberg Retires From Lifetime in Lumberyards

After a lifetime in the lumberyard business, Don Langenberg retired in February.

Although he is 65, Don had planned work a few more years until health issues and an interested buyer prompted him to make the move.

Several years ago, local contractor Steve Edgren planted a seed for thought in Don's mind by letting him know that if he was ever interested in selling Pro Building Supply (615 3rd Ave.) that he would be interested in buying.

"When you have a business like this, and you find a buyer, you probably better let go," Don said.

Don had kept his "ducks in a row" and had several years of profit and loss statements to show to a prospective buyer. Last fall, he took advantage of a PCDC offer to work with the Nebraska Business Development Center to have a business valuation completed.

Steve Edgren celebrated 20 years as owner of Edgren Building in April 2017. But, a recent diagnosis of MS prompted him to consider a different career.

He had recalled mentioning to Don his interest in purchasing the lumberyard several years ago, so he wasn't too surprised when Don called him in November and said he was ready to sell.

The two businessmen worked out the details, and Steve officially took over as owner of Pro Building Supply on Feb. 1.

As a longtime business owner, Steve has a wealth of knowledge in operating a business. But, Steve said he does have a learning curve in transitioning from a service business to a retail business. He is thankful that Pro Building Supply's longtime employees, Carolyn Sievers and Brad Fahrenbruch and several others, who will stay on board.

No major changes are planned in the lumberyard at this time. It will continue to provide anything needed to remodel or build homes, such as hard woods, plywood, shingles, steel roofing and siding, paint, windows, doors and much more. The hours will continue to remain the same, 7:30 a.m.-5:30 p.m. Monday through Friday and 8 a.m. to noon on Saturdays.

Steve's business partner of 12 years, Wendell

Steve began his construction career in high school working for Jim Brown Construction.

Don said Steve's experience as a contractor makes him a great fit for Pro Building Supply.

"I think he will do a great job," Don said.

### **DODGING HIGHWAY DETOURS & ROADBLOCKS**

# Group Offers Solutions During Highway 6 & 34 Construction

The reconstruction of Highway 6 & 34 will limit access to many Holdrege businesses this spring and summer and will surely cause residents and travelers to wonder how to get to the front door of a local restaurant or store.

But, a local group is hoping that with some preplanning and teamwork, business traffic won't be interrupted, and residents and visitors can easily navigate road

closings and detours.

Concrete Solutions 2018

Concrete Solutions

(#ConcreteSolutions2018) is the name chosen for a group whose members will work to assist businesses and residents during the highway project. It is led by staff and volunteers from the Phelps County Development Corporation and the Holdrege Area Chamber of Commerce and area business owners.

The group will help the affected businesses remain successful during the project, which began March 26 and will involve reconstructing Fourth Avenue (Highway 6 & 34) from Garfield to Nobes Street.

The group organized a "Highway Groundbreaking" on March 27 as a kick-off event to help bring publicity to the project.

Allison Fritsche, past chamber president and sales engineer at Glenwood, said the highway construction project in 2015 was an eye-opening experience as traffic counts and sales slowed at many businesses. Communication to customers about how to access businesses was sometimes difficult.

"From the chamber point of view, we need to be a little more proactive this time around," Allison said. "One of our main goals is better community advocacy."

Concrete Solutions 2018 has three main goals:

- To advocate for businesses along the route through pre-planning and education and to share marketing, event or sales ideas to keep customers shopping during the project.
- To keep an open line of communication between local businesses and the state officials

working on the project so that everyone knows the agenda.

• To encourage business owners and customers to remain optimistic, realistic and positive through the construction process.

The initial Concrete Solutions team has been communicating with state highway officials since August 2017 to stay informed on the upcoming project. The first public meeting in February attracted about 100 business owners and residents.

Allison said one challenge the Holdrege Area Chamber of Commerce will face is organizing people and traffic during Swedish Days and the Central Plains Rib Fest, which will occur in mid-June during the midst of the construction project.

Concrete Solutions members are already planning for better signs and communication to travelers entering Holdrege from both the east and west. Signs will state that Highway 6 & 34 is closed, but that businesses can still be accessed.

The committee is also planning other special communication, such as "Highway High Fives" to give the public updates on the project and a weekly "Word on the Street" from the chamber to help businesses share their news during the

construction.



Are you looking for statistics on consumers and shopping patterns in Phelps County? PCDC can help you find the answers. Our organization has contracted with Buxton Co. to provide retail statistics to Phelps County businesses at no cost.

After an initial study, Buxton has showed that Phelps County and the surrounding 20-mile area largely consists of four types of buyers: True Grit Americans, Diapers and Debit Cards, Settled and Sensible, Stockcars and State Parks. These groups are described as people who live within their means, spend modestly or are bargain hunters. This type of information and more is now available at no cost to local retailers or those considering opening a business by contacting PCDC.
